4.1 Executive Director NLLS, James MacDonald – In-person visit and discussion	
Executive Director, James MacDonald, met with the library board to discuss the value of being a member of Northern Lights Library System. This year's Annual Conference is in-person on May 27. The Board Chair conference is on May 26. NLLS is the service hub for public libraries in Northeast Alberta. The highlights mentioned from our visit with James MacDonald includes:	
• NLLS service has 54 municipalities, seven First Nations, four Metis Settlements, and 49 libraries.	
 Frog Lake Library is opening soon and Glendon is starting consultation with the possibility of opening a public library. 	
 NLLS is funded by a Library Board Levy of \$5.23 per citizen plus Municipal Levy of \$5.23 per citizen and Provincial Grants of \$4.70 per citizen. 	
 There will be a policy change to the book allotment which will need to be spent in the first quarter of the fiscal year. NLLS supplies Libby, Overdrive, Hoopla, and Cloud Library 	
 NLLS supplies Libby, Overdrive, Hoopia, and Cloud Library Rates should not increase this year or next year. Population might go up which changes the rate we owe to NLLS. 	None
